

## President's Report



Greg Van Schaack (USCTA President)

Dear Fellow Member:

Last year's Annual Report featured Chicago on the cover. This year is Boston's turn to shine as the Tennis & Racquet Club successfully negotiated a deed restriction that assures the continuation of the Boston tennis court into

the foreseeable future. After a highly successful fund raising campaign lead by the T&R's very capable president, Suzy Schwartz, the roof repair work was completed. I was very pleased with the generosity of our court tennis community. With the help of the USCTA's auction proceeds in 2013, we were able to join with many other concerned players and club members to raise over \$700,000.

Speaking of court development, I am pleased to report that Court Tennis Charleston is making good progress to fund the building of a new court on Daniel Island. With over \$500,000 of pledges, we are well on our way to reaching our goal of \$1.5million. Architectural plans are complete and we have signed a fantastic deal with the Daniel Island Club for the land and the management of the court. All members of the USCTA are encouraged to make a pledge (no amount is too small). Our goal is 100% participation of all USCTA members.

On the game front, the highlight of the year in the U.S. was with the professionals. The USCTA National League gained momentum, as there was greater gallery participation than ever. The matches were close and fun. In the final match with New England (Riviere & Smith) v. New York (Stout & Tanfield), the New Englanders proved too strong for the New Yorkers and took the match 3-0. The host club, Prince's Court, gathered over a hundred members to watch the match and enjoy the camaraderie.

The Eliminators were played on an even more serious note, as the outcome determined who would challenge Rob Fahey for the World Championship. Camden Riviere defeated Tim Chisholm in straight sets in Newport and Tuxedo and Steve Virgona beat Bryn Sayers 7-5 at Queens and Chicago. At the Final Eliminator in Chicago, Camden was impeccable, beating Steve 7-0 to gain the right to challenge Rob. Attendance was high at all the Eliminators, and everything came off flawlessly.

On to the World Championship in Melbourne, where my money was on Camden, albeit I'm biased to say the least. Things started well for our American, as he took the first two sets, but an injury and a talented and fiercely determined Rob Fahey was just too much to overcome and Cam lost 7-3. (Camden extracted a little revenge by beating Rob in the U.S. Professional Singles the following month in Newport). On the junior front, it was made pretty clear to us in our most recent showings in the Van Alen and Clothier Cups that our junior program is in need of serious attention.

To that end, the USCTA, the USCTPF; and the Grassi Family have joined together to fund a series of initiatives to enhance our junior player interest, talent, and performance. The initiatives include clinics, camps and individual instruction for promising junior players. My special thanks go to Temple and Ellie

Grassi for their generous gifts to this program and to our professionals who are implementing it. Finally, this is my last president's report. I'm pleased with the accomplishments of my administration which include helping with the restoration of two courts, beginning the building of another in Charleston, increasing our positive cash position, and almost doubling USCTA membership.

My thanks and praise go to Arnold Spangler, Treasurer; Lex Miron and Jim Zug, Secretary; Peter Vogt,

Membership Secretary; and Peter Pell, First Vice President. I also wish to thank Jane Lippincott for her dedication both on and off the Board to our sport and the communications that we provide for the membership. I know you will all welcome my successor, Mr. Jeremy "record all scores" Wintersteen as your incoming president. Jeremy has been a tremendous asset to our game in his leadership of the U.S. Open Rules Committee and I know he will bring his administrative talents and attention to detail to his new position as your president! I wish you all the very best in your endeavors to improve at our beautiful game. And let us all remember it is just that, a game-we're not curing cancer or solving the Middle East conflict; we're playing a wonderful, engaging sport. Be serious about your practice, want to win, but keep it in perspective. Sportsmanship, courtesy, and traditions are what make our game great.

## HISTORY OF THE USCTA

The first reference to tennis in the Americas extant in the historical record is a decree against playing tennis on Sundays, issued by the Governor of New Amsterdam, Peter Stuyvesant, on October 26, 1656. The centuries that followed were replete with further proof that some version of the "game of kings" was being played in North America. In October 1876, exactly a year and a half after the newly invented game of lawn tennis came to these shores, Hollis Hunnewell and Nathaniel Thayer opened the first bona fide court tennis facility on Buckingham Street in Boston. Over the course of the next 120 years, 18 more courts were built; today there are ten active courts in the US, the oldest in Newport (1880) and the youngest in Chicago (2012).

The United States Court Tennis Association, under the leadership of its first president William L. Van Alen, initially convened on January 30, 1955 in New York. Prior to that time there was no central authority to regulate, promote, and preserve the game in the United States. Indeed, when the Laws of Tennis in America were first adopted on New Year's Day 1934, just three clubs – The Racquet & Tennis Club, The Racquet Club of Philadelphia, and The Tennis & Racquet Club – were signatories.

#### ADMINISTRATION

Besides the promulgation of tennis rules, which were revised in 1979 and again in 2000, the Association has the authority to coordinate and control all national championships and major competitions, and in conjunction with its member clubs, organize and conduct tournaments for all levels of play in America. The USCTA sets the annual tournament schedule and supplies the national level competition medals. The governing body raises funds through membership dues and contributions and by hosting such events as the U.S. Court Tennis Association Annual Dinner and Auction. The USCTA financially backs the construction, maintenance, and restoration of courts, and supports the development of female and junior players. The Association conducts relations with other national governing bodies around the world, promotes international play, and supports the U.S. at international competitions.

#### PROFESSIONAL TENNIS

One of its most essential functions is the vigorous support of professionals in America, without whom the continued existence of the game would be precarious. The Association provides prize money for tournaments such as the National Open, the World Championship,

the U.S. Professional Singles playing for the Schochet Cup and the Men's and Ladies U.S. Opens.

#### AMATEUR TENNIS

The Association also encourages top flight amateur play. It began publishing a list of the Top 25 U.S. Amateur Players in 2004 in order to stimulate competition and increase the level of play, particularly among mid to upper level players. The USCTA also promotes team competition by supplying teams and backing for such international tournaments as the Bathurst Cup.

#### JUNIOR TENNIS

The USCTA is committed to ensuring the future of the sport in America through an active Junior Tennis program. It offers workshops and professional instruction as well as creates opportunities for young players to compete by funding international teams and supports U.S. tournaments like the Junior Nationals and the Lieb Cup.

#### PUBLICATIONS

The USCTA publishes an *Annual Report*, a monthly e-newsletter "*Chase the First*," a fixtures calendar, Top 25 rankings, e-mail news, and other announcements. The USCTA, in conjunction with the USCTPF, also maintains a website.

# USCTA BYLAWS

#### ARTICLE I - NAME:

The name of the corporation shall be The United States Court Tennis Association, Inc.

#### ARTICLE II - TERM OF EXISTENCE:

The corporation shall be perpetual.

#### ARTICLE III - PURPOSE:

The corporation is formed to act as a central coordinating authority between the various clubs which have courts, the individual owners of courts, and all amateur and professional players of the game, and in all other matters connected with the game, so as to foster and promote the game of court tennis and its history.

#### ARTICLE IV - MEMBERSHIP:

Any person, club, corporation, or unincorporated association may be elected to membership upon the approval of the membership committee and the Board of Governors. The Board of Governors shall have full power to designate as many different classes of membership, with their respective prerogatives, together with the dues therefore, as the said Board of Governors sees fit.

#### ARTICLE V - BOARD OF GOVERNORS:

The directors of the corporation shall be known as the Board of Governors. The Board of Governors shall not exceed 21 persons. Representatives elected by member clubs, club representatives, shall serve for the period of one year or until their successors are qualified, or elected in their place and stead. Representatives elected by the membership, At Large representatives, shall serve for the period of two years or until their successors are qualified, appointed or elected in their place and stead:

- a. One representative from the Aiken Club.
- b. One representative from the Tennis and Racquet Club of Boston.
- c. One representative from the Greentree Court.
- d. Two representatives from the Racquet and Tennis Club of New York.
- e. One representative from the Racquet Club of Philadelphia.
- f. One representative from the Tuxedo Club.
- g. One representative from the National Tennis Club of Newport.
- h. One representative from the Georgian Court Club.

i. One representative from the International Tennis Club of Washington, D.C.

j. One representative from the Racquet Club of Chicago. k. Ten At Large representatives to be elected by the membership at the annual meeting, one of whom shall represent the professional ranks. In case of a vacancy, death, resignation, or inability to serve of any of the ten representatives, the Board of Governors shall appoint a succeeding representative for the unexpired term.

There shall be one alternate member of the board from each court. Such alternate member shall attend all meetings of the board and take part in all discussions thereat but shall vote only in the event that the principal member of the board from this court shall be not present.

#### ARTICLE VI - OFFICERS:

- a. The officers of the corporation shall be:
  - 1. President
  - 2. First Vice-President
  - 3. Second Vice-President
  - 4. Secretary
  - 5. Treasurer

b. Each Officer must at the same time of his election be a member of the Board of Governors and shall be elected by the Board of Governors at their annual meeting to serve for one year, irrespective of his continuing as member of the Board of Governors for such period.

c. The President shall be the chief executive officer of the corporation, and shall preside at all meetings of the corporation. The president shall appoint the chairmen of all committees, and shall be an ex-officio member of all committees.

d. The first vice-president shall, during the absence or temporary disability of the president, possess all powers of the president.

e. The second vice-president shall, during the absence or temporary disability of the president and the first vice president, posses all powers of the president.

f. The secretary shall keep a record of the proceedings of all meetings of the corporation, and a list of all persons selected to membership. In addition, he shall conduct the correspondence of the corporation, and shall notify the officers and the Board of Governors, and all members of the committees of their election and appointment.

g. The treasurer shall be custodian of all funds of the corporation, and shall deposit the same in the name of the corporation in a bank or trust company to be designated by the Board of Governors. He shall collect and receive all monies due to the corporation. He shall keep full and accurate accounts of all receipts and disbursements in books belonging to the corporation, which shall be open to the inspection of any member or officer on reasonable notice. He shall make a report of the finances of the corporation at all meetings. His accounts shall be audited by a certified public accountant annually.

#### ARTICLE VII - COMMITTEES:

The president may from time to time appoint chairmen of committees, and describe their powers and duties.

#### ARTICLE VIII - ANNUAL MEETING OF THE BOARD OF GOVERNORS:

The Annual Meeting of the Board of Governors shall take place immediately following the annual meeting of the members. At least two weeks' notice in writing shall be sent to each member of the Board of Governors. Six members of the Board of Governors shall constitute a quorum at any meeting.

ARTICLE IX - ANNUAL MEETING OF MEMBERS:

The annual meeting of the members of the Corporation shall take place no later than June 25 of each year, at such time and place as the Board of Governors shall designate. At least two weeks' notice in writing shall be sent to all members. Nine members shall constitute a quorum at the annual meeting.

#### ARTICLE X - SPECIAL MEETINGS:

Special meetings of the members and of the Board of Governors may be called by the president or at the written request of five members submitted to the secretary, upon seven days' notice to either the members or the Board of Governors. Such notice shall state the purpose for which the meeting was called.

#### ARTICLE XI - AMENDMENT TO BYLAWS:

These Bylaws may be altered, amended, or repealed by a vote of the majority of the members or of the Board of Governors at any annual meeting or at any special meeting thereof, which is called for the purpose, in the notice of which the subject matter of the proposed alteration, amendment, or repeal of the articles to be affected thereby, shall be specified.

#### ARTICLE XII - INTERPRETATION OF THE BYLAWS:

Any question as to interpretation or application of these bylaws and the conduct of the affairs of the Association shall be decided under the laws of the State of New York.

# TREASURER'S REPORT 2013-2014



Arnold Spangler (USCTA Treasurer)

For the fiscal year ending September 30, 2014, we project that we will be in a strong financial position. Our cash is expected to grow from last year and be back at the \$150,000 level. It has been our philosophy to maintain a healthy cash balance in order to support our membership activities, meet our existing expenditures, and finance new initiatives.

Our revenues from membership dues have continued to grow with the opening of the Chicago court and the addition of new members, including more women and juniors to our ranks. Our auction proceeds have continued to be an important source of income. This year's auction raised slightly less than the previous year which was a record. Additionally, over the last few years we have sold ad space in our annual report to help offset publication costs.

We have attempted to continue our policy of holding our expenses in line through careful budgeting. One of our largest expenses is prize money for our professionals. We again made contributions to the U.S. Open, National Open, U.S. Pro Singles for the Schochet Cup, and the National League. In the past we have also supported the U.S. Ladies Open tournament. Recently, we agreed with the United States Court Tennis Preservation Foundation to jointly underwrite a major new initiative for our junior development program. Our other big financial commitment over the last few years has been to our communications group. They have worked hard to integrate existing member records and update our membership database to include current addresses and contact information. Our web site also has been upgraded and expanded to become the primary source of our communications with our members. Tournament schedules and results, relevant articles, pictures, and other pertinent information are now reported in a timely fashion. Another major expense is our annual report. Its publication is a major undertaking and continues to be the source of the yearly historical record. It has been greatly improved and well received by the playing community. Other miscellaneous expenses such as insurance, special events, postage and meeting costs continue to grow.

For the future, we believe it will be important to keep our financial condition healthy in order to serve our growing membership needs and to meet a number of new initiatives and programs as our game expands. We again thank the USCTA members for their strong and enthusiastic support of the Association and its activities.

We will make available the financials for the 2013-2014 fiscal year as soon as our accountants finish them in the fall.

## Notes to Financial Statements 2012-2013

#### THE UNITED STATES COURT TENNIS ASSOCIATION, INC. NOTES TO FINANCIAL STATEMENTS SEPTEMBER 30, 2012 AND 2011

#### NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**NATURE OF ORGANIZATION:** The United States Court Tennis Association, Inc. (USCTA) is a non-profit corporation organized on February 25, 1955 for the purpose of fostering and promoting the game of court tennis for persons of all ages. USCTA's activities include establishing and administering the rules governing the game of court tennis, supporting clinics and special events, and selling merchandise for promotional activities.

**BASIS OF ACCOUNTING:** The accompanying financial statements have been prepared on the cash basis of accounting. Consequently, certain revenues are recognized when received rather than when earned, and certain expenses are recognized when cash is disbursed rather than when the obligation is incurred.

**DEPRECIATION:** Property and equipment are being amortized using accelerated methods over the estimated useful lives of the respective assets.

**INCOME TAXES:** The Association is an organization which is exempt from federal income taxes under Section 501 (c) (4) of the Internal Revenue Code.

**FINANCIAL STATEMENT PRESENTATION:** For the financial statements, USCTA has adopted Statement of Financial Accounting Standard (SFAS) No. 117, "Financial Statements of Not-for-Profit Organization." Under SFAS No. 117, USCTA is required to report information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted assets.

**CONTRIBUTIONS:** USCTA has also adopted SFAS No. 116, "Accounting for Contributions Received and Contributions Made." Accordingly, any contributions received are recorded as unrestricted, temporarily restricted, or permanently restricted support depending on the existence and/or nature of any donor restrictions.

# RAISE THE ROOF: THE TENNIS & RACQUET CLUB RENOVATES

It really began on the last day of January 2009. Like every season, the Tennis & Racquet Club hosted a full slate of events on Boylston Street during 2008-09: the U.S. Ladies Open in November, the annual Patriot Cup and a holiday exhibition match in December, the Burke and Wharton level championships in February, National League matches, a touring side from Newcastle and a Camden Riviere v. Charlotte Cornwallis match a la Bobby Riggs & Billie Jean King—all without a hitch.

But in late January, during the U.S. 50s singles and doubles, trouble came. They got in the Friday matches, but that night it rained and it continued to rain all of Saturday and all of Sunday. "I had to cancel the rest of tournament," said Jimmy Burke, the head pro at the T&R. "It put the club and me and everyone in an awkward, painful position."

How can a court tennis event be rained out?

It can when the roof is failing. There had been sporadic issues and temporary fixes with the T&R's roof for a long while and rain or melting snow sometimes meant a few damp spots or a quick toweling off. But in the first years

of the new century it began to get worse. At times pieces of concrete from the roof would fall down and land on the floor—once Burke spotted a chunk the size of a brick. The rain took the finish off the floor, discoloring it and giving inconsistent bounces. Some of the Thursday night league matches had to be postponed. The court was after more than a century increasingly in need of a fundamental renovation. "It was demoralizing to watch the court deteriorate over the years," said Burke, who arrived at the T&R in September 1986. "It was time for a change." Meetings and discussions after the cancelled U.S. 50s led to a plan. Dev Hamlen, the owner of 939 Boylston, signed a restrictive covenant with the T&R that ensured that the court and dedans on the third floor would always be in perpetuity devoted to tennis (additionally, the racquets court received a twenty-five year covenant).

Tom Dobbins, the longtime manager of the club, headed the repair efforts. All the proposals and bids were analyzed and permits signed. The club had meetings with neighborhood associations. Everything was ready to go and then the great scaffolding shortage of 2012 occurred. Boston was out of scaffolding—perhaps because of the remnant work from the Big Dig—and the club had to wait until 2013 to do the work.

The fundraising effort meanwhile was going full-bore. A key decision was to align the club with the Preservation Foundation. This meant that the T&R became a public club and it enabled all donations to be tax-deductible. George Bell and Jeremy Wintersteen spearheaded the project. One hundred percent of the T&R's board pledged, as did many members of the USCTA and members of the T&R who didn't play tennis. The club charged an assessment, but a small one because so many people in the game stepped up.

There were two milestones in the fundraising: in 2011 when Ellie and Temple Grassi gave \$100,000 to catalyze the fundraising and then a year later at the Chicago opening when they donated an additional \$50,000. Then the USCTA, at its board meeting that same weekend in Chicago, agreed to donate the proceeds from the upcoming 2012 annual dinner auction, an amount that turned out to be \$57,000. "Those were the two key inflection points in the effort," said Suzy Schwartz, the president of the T&R. "Temple and Ellie enabled us to get started, they were the major gift we needed to show everyone that this would happen. And the USCTA, for the first time in its history, decided to give its auction proceeds to a particular project. This showed us that the leaders of the game and indeed all of the game had confidence in our efforts. It was pretty meaningful to have that happen in Chicago that particular weekend-that at the same exact moment we were reopening a court we were deciding that we could not lose an old one."

The actual work finally proceeded in 2013. There were a few hiccups. Because the building is historic, the new roof had to be lined with copper, even though no one can see the roof from the street (you can glimpse the shining copper roof when you fly into Logan Airport). And there were some surprises when the roof was uncovered, including a gap and lack of insulation in parts of the roof. After much debate the club decided to grind the floor and resurface it. "The original idea was to just fix the roof but then we thought why do that when we can finally repair the floor that the leaky roof damaged? We didn't want a ball to bounce on a crack in the floor on the first weekend of play and hit Temple in the head."

Ironically, court usage and interest in the game at the T&R went up during the years when the club was unable to hold tournaments and many afternoons players had to call the club to ask if the court was dry enough to play. The number of Boston players on RTO went from 168 in 2009 to 187 in 2013 and from 88 members of the USCTA to 99. In other words, the club was primed for a renovated court.

At the end of October 2013 the T&R hosted a gala "Raise the Roof" event to mark the official reopening of the court. Jimmy Burke and Tony Hollins hosted tennis supporters from every club in the U.S. and clubs around the world. Thirty doubles teams faced off in five divisions. Nine of the thirty-five eight-game pro set matches went to 7-all; a further eight ended with 8-6 scorelines—very

tight, exciting handicap play. And Camden Riviere and Tim Chisholm, both formerly at the T&R, came back to put on an exhibition with Hollins and Rich Smith. (Additionally, a racquets doubles draw attracted eighteen players.)

Jammed-packed cocktail parties, champagne toasts, completely filled galleries and dedans and a black-tie dinner at the Union Club—it was a very memorable weekend. "It was amazing to be a part of a project that saw the United States tennis community come together to bring the Boston court back to life," said Tony Hollins. The transformation didn't just reignite a passion in the existing players at the club; it also caught the eye of members who had never thought of stepping onto the

court before. Since the reopening we've had more than forty new faces on the court and seen a huge increase in court usage."

After the court came back into play, morale shot back up and the booking sheet got congested. The club hosted a half dozen tournaments through the winter, touring sides and a lot of curious visitors who had been playing tennis for years but never had been able to get on the court in Boston. This past summer, the sixty summer members at the T&R jumped at the chance to play on the new court.

## **Club Reports 2013-2014**



NEWPORT, RI (1880) NATIONAL TENNIS CLUB By Stephen J. De Voe III

The past season has been a good one for the National Tennis Club (NTC). We have seen our membership grow, our finances remain positive, our players' performances improve, and our tournaments thrive thanks to the welcoming environment created by our club professionals. We are truly blessed, nevertheless, we are and will be working tirelessly to improve in all of the aforementioned areas.

Membership has increased slightly over the past year with all categories at or near all-time highs. We are particularly pleased with the growth in women and junior memberships. These two groups represent an underdeveloped resource for us and we intend to work on making our game attractive to both groups. We aim to include all of our members and professionals in the overall recruiting process by maintaining a friendly and welcoming environment for all new players, particularly fueled by our popular "Taste of Tennis" program. The process is clearly working. We reached a turning point in court usage this year as the one hour and fifteen minute time allotment had to be reduced to one hour to create more slots for members and guests to play. As a result, court usage reached a level exceeding 95%. The club room is usually busy with a number of players coming and going. This high court usage is facilitated by our professionals who do their best to see that no one is stood up and doubles matches actually include four players. Our posting of scores in the RTO System

continues to be the highest for all US courts, making our members' handicaps more accurate for play both here and abroad. Newport players continue to travel to all parts of the world to compete and carry the banner and message that court tennis is alive and well in Newport. As we are wont to say, Newport is a very warm and welcoming place. Come and play with us. You won't regret it.

The NTC hosts a number of tournaments throughout the year. All of these events are set up and managed by our tennis chairman, Brewer Rowe, and our head pro Richard Smith. With the support of our Board and all the members, we are fortunate to host two top tier events each year: the United States Professional Singles playing for the Schochet Cup, in which the highest levels of court tennis in the world are on display; and the Pell Cup in August, which features a wide range of talented players both amateur and professional. Both of these events bring the world's best to Newport. This year was no exception with nine of the world's top ten playing in the U.S. Pro. All in attendance were treated to awesome matches from the preliminary rounds through to the finals. Both Camden Riviere and Rob Fahey were kind enough to participate after their grueling duel in the World Championship. This time Camden came out on top, winning in four sets. The final was a wonderful morning of tennis with both players in good form, demonstrating excellent sportsmanship and brilliant tennis. This event could not happen without the steadfast support of all of our sponsors. We give thanks to all of our sponsors — particularly Jay Schochet and Northfield Information Services — whose support, combined with many generous donors, provides one of the largest tournament purses in our game. If you haven't been to the U.S. Pro/Schochet Cup, please join us next June. Newport weather is clear and inviting, all the

pros are here – Why not you? On a very partisan note we could not have been more proud of our own new pro Ricardo Smith who advanced to the semifinals in his first tournament under the NTC banner. Ricardo finished the tournament ranked sixth in the world and we are fortunate to have him as one of our pros.

On the national front, Pat Winthrop continues to hold one of the top rankings on this side of the pond along with several of the more prestigious titles. Amanda Avedissian is ranked no. 1 for U.S. Women (no. 7 in the world) and Petra Napolitano in the top 15. Board member Kaveh Nazemoff won the Hickey Cup. On the junior side, John Harkins won the U.S. National Under 18 title and John along with Pete Dickinson won the Under 18 junior doubles title. John was also the recipient of the USCTA's Most Improved Junior Player Award presented in December at the USCTA Annual Awards dinner. Our fifteen to twenty juniors enjoy two lessons a week courtesy of the foresight of the late John Lieb and the Lieb Foundation. While we are proud of our own junior program, we are excited about the prospects for an active national junior program thanks to the generosity of Ellie and Temple Grassi through the Thornedge Foundation which will benefit both our own junior players, and those throughout the country. Both of our pros are excited to work on the recruitment and development of junior players in Newport and throughout the country.

On the physical side of things, the International Tennis Hall of Fame, which is responsible for the maintenance of our physical plant, continues to keep the court free of most leaks and the facility in good shape. Board member John Damon takes care of everything they don't and with the guidance of Bill Burgin, former President and current Board member, continues to upgrade those areas that need improvement. The environment is clean and welcoming thanks to their efforts.

Last year we finally moved into the twenty-first century with a new web site. We put a tremendous amount of energy and time in making sure it is accurate, timely and useful. This effort is managed by Board member Petra Napolitano and her committee. We record all of our tournament scores as they happen and make an effort to keep members informed when a group travels to any other venue by posting their results as they become available. Please visit our site www. nationaltennisclub.org to view what is happening, what's going to happen, tournament draws and, of course, some great pictures. Inspired by the world's video streaming we are in the process of upgrading

our audio-visual capabilities but more of that in next year's report. All I can say is it's going to be really good. Live video streaming has become a major part of our game and we are in the process of upgrading our own audio-visual capabilities. Look for our report next year, in the meantime, all I can say is that it is going to be really good.

With regard to professionals the NTC continues to be blessed. Ricardo Smith joined us in January. A better young senior professional cannot be found. He has made himself at home and together with Richard Smith, our long time Head Professional makes quite a duo. Tom Rowe said this last year and it has only gotten better, "Quite simply we have two of the best pros in the game. They make the club a pleasant place to visit, they teach us how to play the game, and they make the total experience one of pure pleasure." I can't add anything to that except "Thanks Guys." So it's on to next year... I can hardly wait.

LAKEWOOD, NJ (1899) Georgian Court By James Zug

Lakewood, under the direction of Schuyler Wickes, has had another fine season.

It was an historic one: it was exactly a hundred years ago when Lakewood's greatest product, Jay Gould, won the men's world championship, 7-1 in Philadelphia in March 1914. Gould's victory was the only time an American-born player became world champion between the start of regular competition in 1885 and Norty Knox capturing it in 1959.

This year was also the first time Georgian Court University enrolled male undergraduates, so men began to regularly gather again on the famous court.

For the third year in a row, Neil Smith was the professional-in-residence, a role for which the USCTA gave him the 2013 Professional of the Year Award. Smith is the first regular pro at Lakewood since Frank Forester held court more than a century ago. Smith led twenty-five Tuesday night clinics over the course of the school year, again inspiring the GCU community to take advantage of their precious court. One player, Melissa Mikkelsen, ended up attending tennis tournaments in New York, Philadelphia and Aiken and led an effort to charter an undergraduate tennis club at GCU. Mikkelsen also ordered some new GCU tennis kit, prominently featuring the new, Jon Crowell designed logo.

The fifth-annual Lakewood Invitational again came off in September. As usual, it was anchored by players from Boston and Washington meeting halfway in between in central New Jersey. All players got in at least five sets of doubles.

In the spring, Jesmond Dene came through and like all other tennis players on tour, were amazed at this special court. There are thirty-five Vermeer paintings in the world and there are thirty-seven clubs around the world where you can play a proper game of tennis. In other words, Lakewood is like a rare Vermeer.

TUXEDO PARK (1900) TUXEDO CLUB By Josh Scherer

The resurgence of court tennis at Tuxedo continues, due in large part to the tremendous effort of Tuxedo's head professional Tim Chisholm. Over the last two seasons, assistant professional Josh Dodgson has provided energetic support helping Tim further develop all five racquet sports at Tuxedo. In the last two years, approximately fifty members of the Club have taken up court tennis. Highlighting the heightened activity on court, we had record participation in Pennant, a club competition consisting of 4 teams: Greevy's Greats, Moore's Magicians, Gannon's Gladiators and Forrester's Fanatics. Over 100 matches and 2,500 games were played by fifty-four enthusiastic competitors!

The surge of enthusiasm for the game by this new crop of players has also translated into significantly greater travel and participation at tournaments across the country. In the 2013–2014 season, members travelled to Boston (Raise the Roof, USCTA 40s and 50s), Chicago (Wharton Cup, USCTA 60s and 70s), New York (Etchebaster, Silver Racquets), Philadelphia (Lord Percival Cup), and Washington, DC (Cherry Blossom). Emphasizing this emerging travel trend, Tuxedo members also represented the Club in racquets at the Canadian Amateurs in Montreal, the U.S. Amateurs in Detroit and the Kendrick Cup in New York.

During the season, the club hosted two events: the 112th Gold Racquets and one leg of the World Championship Eliminators. Conspicuously missing from the season's calendar was the Hadden Tomes Tournament. In

Philadelphia (1907) The Racquet Club of Philadelphia By Peter Vogt

The past year was hugely successful for court tennis in Philadelphia. We hosted several national events. Our club tournaments were highly competitive and entertaining. While many of the old regulars prevailed, some relative newcomers demonstrated that they are becoming forces to be reckoned with.

Our most important addition this season was our new assistant professional, John Lumley. John made his presence felt immediately by showing great playing skills and enthusiasm for teaching our players how to improve their game. In September, he defeated Camden Riviere in a National League singles match, which put him in a very small club indeed.

The tennis season in Philadelphia gets into high gear with the Jimmy Dunn. This year Rob Whitehouse teamed with Rich Smith and avenged last year's finals loss by beating Barney Tanfield and Lex Miron to win the Open Division. The other division winners were Ryan Carey and Kris Motz in the A, Jim Zug and Gary Swantner in the B, Richard Gilder and Jake McCray in the C, Baird Standish and Richard Griffith in the D, and Amy MacMillan and Jennifer Metzler in the E.

The highlight of the weekend was the dinner honoring Ed Noll, who retired this year after more than forty years of service. Ed started as a teenaged assistant pro under Jimmy Dunn and went on to become head professional and then general manager. He was responsible for much of the Club's success on and off the court during his tenure here. Among many funny and moving testimonials, the best moments came when Mike Noll, also a former RCOP tennis pro, gave tribute to his father. Thanks Ed for all that you did for us!

Fittingly, the Noll Cup was held in Philadelphia in January. A strong field of players vied for the trophy. The last two men left standing were Dick Tanfield and Geoff Ellis who played an epic final. In the end, youth trumped experience as Ellis squeaked the match out 6-5 in the third.

The U.S. Amateur came to town in March. In the singles, Jon Crowell had a great three set win over Danny McBride before succumbing to Mark Mathias in the semis. The final between Mathias and Pat Winthrop was a showcase of two of the best young players in the game.

Mathias started strongly, winning the first set and taking an early lead in the second, but Winthrop ripped off six games in a row and won the set. Mathias won the third set convincingly only to see Winthrop race out to a big lead in the fourth. But Pat stalled after he won the fifth game and Mark came back to take the set and the match. The doubles final was even more exciting than the singles. Mathias teamed with James Gould against Lex Miron and Tom McGinnis in a match that went five sets. Miron and McGinnis seemed to have matters well in hand when they jumped out to a 5-1 lead in the fifth set, particularly since Mathias looked tired from his earlier singles match against Winthrop. But then the tide turned and Mathias and Gould cut the deficit to 5-4. At this point, McGinnis stepped up and made several gamesaving shots. But McGinnis saved his best for match point, returning a superb Mathias railroad for a winner by hitting it off the winning gallery bandeau.

Teams from Aiken, Chicago, Washington, New York, and Tuxedo spent St. Patrick's Day weekend in Philadelphia competing for the Lord Percival Cup. The RCOP fielded two teams but neither was able to gain the final. Instead, it was the New York team hoisting the plate after beating one Washington team in the semi-final and the other in the final.

Philadelphians enjoyed great success at several levels of the national championships. Dick Tanfield won the U.S. 70s singles and doubles. Paul Monaghan won the U.S. Under 21 singles for the third consecutive year and the Under 21 doubles, while Spencer Yager and Sebastian Yager were the runners-up in the Under 18 doubles. In the Club championships, Jon Crowell successfully defended both his singles and doubles titles. He teamed with

Christian Bullitt to beat Norris Jordan and Tom Brownlie in the doubles and triumphed over surprise finalist Kenny Soffer in the singles. The Racquet & Tennis Club's professionals, Mike Gooding, James Stout, and Barney Tanfield, led the club once again to a great season. Along with a well-attended National League match, the USCTA Annual Dinner and Auction, and several matches with travelers from English clubs, the R&TC hosted the following USCTA events this season:

Silver Racquet Amateur Singles New York Open Handicap A, B, & C Singles Whitney Cup U.S. Open Etchebaster Cup U.S. Over 70s Singles and Doubles

#### Silver Racquet & New York Open Handicap

The 21st annual Silver Racquet began with a well-attended and fittingly boisterous stag dinner on Thursday night in memory of Eddie Ulmann. Generations of fellow batsmen shared hilarious stories throughout the dinner, helping to build on Ulmann's considerable lore. The climax of the tributes was when Racquets, Tennis, and Squash Committee Chairman, Morris Clothier, announced that the Racquets Court would be rededicated in Ulmann's honor.

Play began in earnest on Friday morning. Singles tennis titles up for grabs were the Silver Racquet Invitational and three flights of NY Open Handicaps. The weekend also included two strong racquets draws (the Silver Racquet paired doubles and the first iteration of the U-35 Handicap Singles) and the Silver Racquet Invitational Squash Doubles, which proved to be one of the highest level amateur doubles squash tournaments of the year.

Tennis matches were hotly contested from the start. Notable early matches in the Invitational included tense three setters between John Prenn vs. Jeremy Wintersteen and Lex Miron vs. Jonathan Larken. NY Open Handicap matches were first to eight game affairs. Players representing clubs from around the world displayed plenty of athletic prowess and exciting matches throughout the NY Open Handicap flights. As an example, Paris' Philippe Travis ousted seven-time US national squash champion Julian Illingworth in the first round of the B flight.

Following the 550+ strong, always epic dinner dance on Saturday night, battles of will characterized the latter rounds of play on Sunday morning. The R&TC's own newcomer

Peter Roessler found a relatively easy route through the middle of the C draw to the finals against Tuxedo's Josh Scherer. Roessler's good gets and use of a racquets-inspired force paved his way to the title.

Paddle tennis maven Ben Stein cruised through the handicap

B flight to meet Will Hartigan in the finals. In a close match throughout, Stein's consistency and avoiding the penthouse were just enough for the title.

The A handicap draw featured an impressive run to the finals from the R&TC's Tom McGinnis. He ousted former A champions Zach Sacks and Peter Pell on his way to face Washington's (via the UK) Mark Mathias in the finals. Mathias was having quite the weekend, having dropped only eight games en route to the Invitational finals and defeating, among others, World Racquets Champion James Stout to reach the A Handicap finals.

Scheduled to play back-to-back finals beginning at noon on Sunday, Mathias dispatched the hard-hitting McGinnis with punishing forces and purely-hit floor shots. No matter what McGinnis tried and how close the game score got, Mathias replied relentlessly with flat, center-struck balls. 8-6 to Mathias in the A handicap.

Next up, the Invitational. Having prevailed over Miron in this year's Jimmy Knott final in Newport, the mild-mannered Mathias followed a familiar game plan in what, prior to this tournament, was an unfamiliar court. The Brit's fizzing railroads, extrasensory anticipation, and pure strokes proved too much for an on-form Miron. In a fantastic display of tennis overall, Mathias prevailed in a close two sets.

#### Whitney Cup

Defending champion New York began the weekend ready to make a run at a third straight title. Last year's finalists Greentree-Aiken entered with hopes of claiming its first title since 2010. Completing the six-team field were veteran teams from Philadelphia, New England, Washington, and Tuxedo-Chicago.

Play in Group I (New England, New York, Tuxedo-Chicago) started Friday morning with New England taking on Tuxedo-Chicago. In taking the first four matches in convincing fashion, dropping fewer than two games per set, New England announced loudly its return. In Group II (Greentree-Aiken, Philadelphia, Washington), Greentree-Aiken dropped only one set in a 5-0 win over Philadelphia.

With New York taking on Tuxedo-Chicago and Philadelphia's battling Washington, Group II play started late Friday afternoon and continued on Saturday morning. Despite many close games, New York and Washington each moved out of the round with 5-0 wins.

Second round matches featured New England vs. New York and Greentree-Aiken vs. Washington. The New York vs. New England match was exciting up and down the roster, with top-quality tennis on display. In the end, New York prevailed 4-1, reaching the finals for the third year in a row. While the Greentree-Aiken vs. Washington skirmish included three hotly-contested, three-set matches, last year's finalists moved on to the finals with a 5-0 win.

Sunday's final started with the seniors on the East Court (Simon Aldrich/Bob Hay vs. Bruce Manson/Chris Moore) and number four teams on the West Court (Rakesh Jasani/ Jason Mengel vs. Antony Smithie/Will Thompson). Within an hour, Greentree-Aiken was up 2-0 in matches. At number one, Cook and West were determined to close the match in Greentree/Aiken's favor. Behind a circumspect serving plan and consistent, high-energy play, Ben Cook and Addison West clinched the Whitney Cup for Greentree-Aiken with an impressive straight set win over Spike Willcocks/Chris Arriz. Dropping only one match of fifteen played in its championship run, Greentree-Aiken took the Whitney Cup with authority!

#### U.S. Open

New York City's relentless Polar Vortex unceremoniously greeted many players' arriving warm from the recent Australian Open in sunny Melbourne. Despite its proximity to the World Championship Eliminator, generous support of this year's U.S. Open from the USCTA and from many local court tennis enthusiasts helped to ensure a top-caliber draw.

The early rounds featured some notable performances. Mike Gooding, R&TC's Head Professional, put in a great effort against Kieran Booth, the world's highest-ranked amateur. While the tight, three-hour contest thrilled the forty-nine year old Gooding's local support base, Booth prevailed in four sets. Booth's consistent play continued in the quarterfinals; the Australian outlasted an on form Ricardo Smith in five close sets. In a bid to capture his second U.S. Open singles title, James Stout, R&TC's Head Racquets Professional, kept his hometown supporters engaged with a four set win over Ben Matthews in the quarterfinals. Stout entered the semifinals against Tim Chisholm, Tuxedo's Head Professional, as the underdog. In what was perhaps the most exciting match of the tournament, Stout and Chisholm exchanged blistering pace, bewildering spin, and stunning gets throughout the five set thriller. In the end, Stout out-touched the veteran Chisholm, 6-5 in the fifth.

Camden Riviere put his World Championship caliber form on full display through to the finals, losing a total of only nine games. In the Finals, Riviere's impeccable control unceremoniously neutralized Stout's otherwise brilliant play. Riviere stamped firmly his mark on his third U.S. Open Singles title, dropping only one game in the finals. With Chisholm, and in dominating fashion, Riviere also went on to capture his third U.S. Open Doubles title over Stout and Gooding.

#### Etchebaster Cup

With a record forty-nine entrants, this year's Etchebaster Cup was a resounding success. Held jointly with the racquets' equivalent of the Etchebaster, the Kendrick Cup, multitalented racquet sports enthusiasts filled both draws. A high level of play pervaded throughout the tournament to leave two relatively new players, Peter Cipriano and Will Hartigan, in Sunday's finals. Cipriano's consistent length and home court knowledge prevailed over Hartigan's considerable athleticism. In short, the weekend made clear that the tide of young talent is indeed rising.

#### Over 70s

The U.S. 70s championship attracted a small but enthusiastic group of participants. The evergreen Dick Tanfield of RCOP progressed through to the final with little resistance, seeing off en route two R&TC members, Bardyl Tirana and Michael Flinn. In the other half of the draw, Jonathan Pardee of Newport came up against a very determined John McLean. The two battled over three hours, with the younger Pardee prevailing narrowly in what was the match of the tournament. The singles final saw a fresh-legged Tanfield race away with the first set without dropping a game. To his credit, Pardee clawed his way back into the match, leveling the second set at four games all. Tanfield gathered his composure and captured the set and the Singles title.

The first set of the Doubles Final was nip and tuck all the way; but, Tanfield and Pardee just edged it out 6-5. The New Yorkers, McLean and Flinn, dominated the second set and third sets' rallies with strong volleying and determined retrieving, taking the second and third sets 6-4 each. It was an excellent weekend of tennis overall for the game's wizened troupers.

CHICAGO (1924) THE RACQUET CLUB OF CHICAGO By An Observer

Another tremendous season marked the second year for the Racquet Club of Chicago. Play amongst our membership has been steadily increasing as more members took up the game and our existing player base continued to play and improve their games. The court is booked on average seventy-five hours per week with lessons, matches, clinics, leagues and tournaments.

The Chicago Invitational weekend kicked off the season in October and was a huge success both on and off the court. Sixty players competed in four divisions in some very competitive tennis.

Joe Tomaino served an unreturnable serve at match point to win the C Division with Arthur Drane over Jay Leonard and John Broussard. Len Mazzone and Charles Buaron took the B Division with a close win over John Murphy and Ben Ringrose.

Despite being hit in the head by a ball in the semifinals, Jamie DeYoung showed his mettle by winning the A Division with Anders Cohen. They defeated the favorites — Adam Inselbuch and Rowan Carroll — in a match that featured fast volley exchanges at net, classic length, and fierce forcing of the openings.

Greg Van Schaack and Steve Virgona won the Open Division over Rich Smith and Jeremy Wintersteen. Van Schaack and Virgona won the first set handily, but Wintersteen and Smith were not going down without a fight and won the second set 6-4. The standard of play from the amateurs was high in the final set as Smith and Virgona upped the pace. Van Schaack had amazing reflex volleys from the galleries while Wintersteen defended against Virgona's dedans forces with tremendous skill. At 40-all, match point, Van Schaack played a superb reaction volley to the base of the tambour to clinch the match 6-1, 4-6, 6-5.

Chicago hosted several USCTA tournaments during the year including the Wharton Cup, the U.S. Amateur Mixed Doubles, the Anne Boleyn Handicap Singles and the U.S. 60s Singles and Doubles. Wes Koontz won the Wharton Cup in a tight match over surprise finalist, Dara Walsh from Prince's Court. The match could have gone either way, but Koontz consistently won the key points. Gary Multer staged a comeback, saving two match points, to win the consolation final over Webber Scott. The U.S. Amateur Mixed and the Anne Boleyn — a

women's handicap singles tournament —were held on the same weekend and attracted players from Chicago, Newport, Boston, Washington and the UK. Freddy Adam teamed up with Davis Anderson to win the Mixed over Helen Grassi and Jason Briggs.

The Anne Boleyn final featured two former collegiate lawn tennis stars — Elizabeth Dolan and Farley Lansing — both of Chicago. Lansing took the match 8-3. Good competitive matches, fantastic food and lots of laughs combined for a successful weekend in Chicago.

The U.S. 60s were held during the Final Eliminator weekend in March. Greg Van Schaack captured his sixth consecutive singles title over Charles Johnstone — 6-5, 6-3. Van Schaack, partnered with Howard McMorris to claim his sixth doubles title over Johnstone and Vern Cassin — 6-4, 6-3.

The club also hosted the second and third legs of the first eliminator matches and the Final Eliminator match to determine the 2014 World Championship challenger. The first eliminator was played between Steve Virgona and Bryn Sayers. With Head Professional, Steve Virgona, looking to get to the World Championship for the third consecutive time, the club was in a state of excitement. Virgona had defeated Sayers in the first match at the Queens Club and needed one more win in Chicago to get to the Final Eliminator.

Over 110 spectators packed the club on the night of the match and anticipation was high, as for many it was their first glimpse of world championship level tennis. To no one's surprise, the crowd favorite was decidedly Virgona as Sayers, although one of the world's top players, had never played on the Chicago court was an unknown entity.

Virgona took the first two sets easily winning 6-2, 6-3. A "not up" call against Sayers was a turning point, however, as Sayers, dissatisfied with the call, came back with a new intensity. After a back and forth set, Sayers took the lead at four-all and won the third set 6-4. The fourth set belonged to Sayers who upped the pace with Virgona making errors and missing targets. Sayers won the set 6-1.

Virgona took a 4-1 lead in the fifth set, but Sayers dug deep and brought the score back to 4-3. The crowd was going wild as Virgona went up 5-3 only to have Sayers fight back to five-all. Sayers, down 40-15, fought off multiple match points to win the set and the second leg 6-5.

Forty-eight hours later another packed house awaited the third and final match as all were hoping to see the same caliber of tennis, but with a different result. They were not disappointed. Sayers took the first set 6-1, but Virgona coming back from being down three, won the second set 6-4 and the third set 6-1. Despite a valiant effort by Sayers, Virgona kept the pressure on and won the final set and a ticket to the Final Eliminator, 6-3.

The Final Eliminator between Virgona and Camden Riviere was a rematch of the 2010 contest when Virgona beat Riviere in the "thriller from Tuxedo" match seven sets to six. Riviere came out strong and took a 5-1 lead, but Virgona fought back to tie the set at 5-all. Virgona fought off several set points, but Riviere took charge and won the set 6-5. Despite some great tennis from both players, Virgona was unable to capitalize on his chances and Riviere, playing a consistent error free game, took the lead after the first day 6-5, 6-3, 6-1, 6-1.

The crowd was anticipating Virgona to stage a comeback in the second day. It was apparent, however that he wasn't at his best physically, and despite a spirited attempt at a comeback, Riviere proved to be in command. Riviere won the final three sets to claim the right to challenge World Champion Rob Fahey in Melbourne.

In addition to the U.S. 60s during "eliminator week", the club ran a Final Eliminator Handicap Doubles. Freddy Adam and Nick Browne defeated Anders Cohen and Amanda Avedissian in a spirited final. The week was a great success in terms of play and was a great advertisement for court tennis in Chicago. The week's events were well-organized by the Athletic Chairman, Brad Schwalm. Our second season came to a close with our club championships, which, as always were keenly contested! Thanks to our pro staff for their hard work throughout the season and for making the game so enjoyable for our membership. We have more than 120 active players, court usage is at an all-time high and our members are actively participating in leagues, clinics, tournaments and social matches. We are looking forward to hosting USCTA events in the 2014-15 season.

A large crowd turned out to watch the National League finals, and to attend the Club's annual holiday party (complete with a court tennis themed wine-tasting



## USCTA Membership Report 2013-2014




